**Uwharrie National Forest Trail Strategy
Compilation of Information for All Trails**

The following information and tables are compiled by Environmental Planning Strategies, Inc. from all information and data found from the following sources:

- Information documented on the Uwharrie NF website from the Public and Forest Trail Strategy efforts conducted in September 18, 2014, December 10, 2015, and September 24, 2015
- Uwharrie NF GIS maps created October 24-25, 2017
- Uwharrie NF District Recreation Staff Officer Terry Savery and Uwharrie NF District Ranger Michael Spisak
- Uwharrie NF Land and Resource Management Plan 2012 and Final EIS

The Forest Plan and EIS information in Part 1 includes information, guidance, and planning frameworks related to trails and recreation.

The compilation tables in Part 2 are a complete summary compilation of available information regarding all existing trails and proposed additions, rehabilitation, closures, and reroutes identified by Forest staff and the public.

The next decision that needs to be made by the Uwharrie NF District Ranger is: Where do we go from here? This organized compilation, with all necessary information in one place, will assist the Uwharrie NF to make an informed decision on the direction and approach for setting priorities for:

- Modifications to the Uwharrie NF motorized and non-motorized trail systems
- Priorities for trail management
- Archaeological resource and botany surveys
- NEPA compliance strategies for furthering the trail recreation program on the Forest
- Public engagement for the further development and implementation of the Trail Strategy

Part 1A. Uwharrie NF Forest Plan Guidance (May 2012): Trails

3	Niche	Providing outstanding and environmentally friendly outdoor recreation opportunities, with excellent trails and facilities: It is a challenge to provide the kind of experience recreationists want while minimizing impacts to other forest resources and other forest users.
14	DFC REC: - REC-1	Outstanding recreation opportunities draw visitors to the Uwharrie NF, provide opportunities for visitors to experience natural forest settings while enjoying physical activities with family and friends, and provide economic benefits to the local communities. Conflicts among users are rare.

14	REC-2	Expanded recreation opportunities are provided outside the Badin Lake area.

15	REC-4	For the Badin Lake Recreation Area: the recreation sites are well maintained; the information and fee boards are up-to-date and provide appropriate information to the public; user conflicts on trails, roads, and within the recreation area are minimized; recreation impacts to the natural resources and cultural resources are reduced through improved conservation education programs, signage, and interaction of Forest Service employees with the users of the national forest.

16	TRL-6	Mountain biking occurs only on roads and designated trails and areas in several parts of the forest. Mountain biking does not occur on roads signed as closed to bikes. Bike trails are well designed and maintained to provide varied user experiences (easy to more difficult) while minimizing resource damage. While on the bike trails, visitors seldom see evidence of litter or erosion. No visible sediment is entering streams from the trails.
16	TRL-7	Horseback riding occurs only on a designated system of trails, roads, and areas. Riders are informed about how to ride safely in traffic. Horse trails are well designed and maintained to provide varied user experiences (easy to more difficult) while minimizing resource damage. Trails do not usually coincide with roads and crossings occur at designated locations. While trails avoid wet areas, access is available to horse watering areas. While on the horse trails, visitors seldom see evidence of litter,

16	TRL-8	OHV use occurs only on a designated system. An OHV trail system exists that is well designed and maintained to provide varied user experiences (easy to more difficult) while minimizing resource damage. Trails are available for full-size OHVs as well as other types of off-highway vehicles. Designated OHV routes are clearly defined on maps and on the ground, and off-highway vehicles are operating only on designated routes and during the established open season. Trails are free of litter, and no visible sediment is entering streams from the trails.
16	TRL-9	Well-trained partners and volunteer groups are working to maintain or improve the trail systems.
16	DFC FAC: FAC-2	Parking areas and trailheads exist for users at convenient locations and are well-designed for their intended use, including parking for vehicles towing trailers to the OHV area and horse trails. Forest users are parking in a safe manner along roads: not blocking roads, and not impacting adjacent landowners.
18	DFC: VIN VIN-1	Visitors have access to accurate maps and detailed information so they can have a safe, positive experience in the forest. Information on trails includes distances, difficulty, and trailhead locations.
19	VIN-4	Visitors are informed about ways to lessen their impact on the environment, including the importance of staying on trails; minimizing impacts to soil, water, vegetation and wildlife; not littering in the forest or leaving trash at campsites, parking areas, or the shooting range.

23	Obj:	During the planning period approximately 10 road or trail crossings are maintained to improve water quality. Controlling erosion from roads and trails is crucial in preventing sedimentation of streams.
26	REC approaches	The strategy for trails and dispersed recreation includes developing site-specific recreation plans (separate from the Revised Land and Resource Management Plan) as funding permits. We will work to bring all trails to a sustainable standard by redesigning and reconstructing the trail system as necessary to accommodate the designated type of use and to eliminate impacts to resources. This work may include rehabilitating trails in place or relocating trails as necessary. In this regard, the Forest Service recognizes the need to establish and maintain relationships among forest personnel and user groups. Our focus first will be on correcting long standing problems with the trail systems in the Badin Lake Recreation Area, to reduce impacts to water quality and cultural resources, and provide a better experience for users of the horse and OHV trails. One way to facilitate trail improvements is to apply for trail improvement grants on a regular basis. It will also be increasingly important to develop strong partnerships with trail users to help with maintenance of trails and to help share information about proper trail use with new users. Volunteers and cooperators are actively working to secure funds and identify land suitable for sale, exchange, or easements that would fill in the gaps between national forest system parcels. The main strategy for developed recreation is to finish current construction projects and fix or maintain current facilities. Another strategy is to encourage more consistent use of existing facilities, including on weekdays. Some facilities are full on weekends, but remain sparsely used during the week. Additional facilities will be provided only after evaluating the financial sustainability, environmental sustainability (including capacity of use), and operational effectiveness of the potential facility, as well as the Forest Service's ability to adequately clean and maintain additional facilities.
30	Obj:	We support establishment of a 'Friends of Uwharrie National Forest' group.
36	S&G SWF-G-6	New or re-routed roads or motorized trails should be located at least 100 feet from perennial streams and at least 50 feet from intermittent streams, except for designated stream crossings.
36	G-7	New or re-routed non-motorized trails should be located at least 33 feet from perennial and intermittent streams, except for designated stream crossings and horse watering sites.
36	G-7	Where roads or trails cross streams, crossings should be at right angles where possible.

There are standards and guidelines that would apply to the location of trails, particularly near water, but no MA is unsuitable for these uses.

3/143-145	Recreation Baseline	<p>The USDA Forest Service's National Visitor Use Monitoring program estimated that in 2008 there were close to half a million visits to the Uwharrie National Forest. The percentage of visitors that came to the Uwharrie NF for varying recreational activities was estimated from the 2010 Montgomery County Tourism Development Authority Survey of Visitors to the Uwharrie National Forest. The percentages indicate that the majority of visitors to the Uwharrie NF camp and use the trail systems. The trail use from highest to lowest order is hiking, horseback riding, OHV or 4-wheel driving, and mountain biking. With the majority of the campgrounds, OHV trails, and equestrian trails being concentrated in the Badin Lake Recreation Area, these figures indicate that there is a lot of recreation use in a relatively small area on the Uwharrie National Forest. \$-wheel Driving 11.2%; mountain biking 1.8%; horseback riding 13.5%; hiking 17.1%</p>
3/145	Trails Baseline	<p>There are currently 121 miles of designated system trails on the Uwharrie NF. Of this total, approximately 17 miles are designated as motorized OHV routes for the full range of OHVs, 40 miles are designated as equestrian/mountain bike and hiking trails combined, 16 miles are designated as hiking/mountain biking trails, and 48 miles are designated as hiker-only trails. The majority of equestrian use occurs in the Badin Lake Recreation Area on the 40 miles of designated trails, as well as, cross-country throughout the national forest. The majority of the mountain bike use occurs on the trails in the Wood Run area. All these uses have become increasingly popular on the Uwharrie NF, especially equestrian and OHV use because of limited opportunities elsewhere in the Piedmont region of North Carolina. Based on the Montgomery County Tourism and Development Authority User Survey displayed in the table above, the total percentage of visitors that utilize trails or cross-country riding during their visit to the Uwharrie NF is 43.6 percent.</p> <p>The Uwharrie National Recreation Trail (Uwharrie Trail) is a hiking trail that follows a north-south route through the national forest. Several conservancy organizations and the</p>

		Forest Service are working toward protecting the entire length of the trail with the goal of eventually putting as much of the route as possible on public land. This need was identified in the public collaborative planning process. At present, only about 50% of the desired route is on public land.
3/145	Trails Baseline	Increasingly, adjacent private landowners are creating their own trails from their private property onto the national forest. These trails may be for all-terrain vehicles (ATVs), dirt bikes, mountain bikes, horses, or hikers, depending on the individual landowners and their preferred type of recreation (note that OHV use – which includes ATVs – is only authorized on the designated system so adjacent landowners accessing the national forest from their property by ATV or dirt bike is in violation of law). These adjacent private landowners are currently enjoying a freedom to access the national forest directly from their homes, which they highly value.
3/146	Trails Baseline	There are approximately 54.5 miles of non-system trails in the Badin Lake area alone that are causing issues for trail users and impacting natural resources. Table 3-27 shows the amount of system and non-system trails in the Badin Lake Recreation Area. There are approximately 117 miles of system and non-system trails in the three watersheds that make up the Badin Lake Recreation Area. While system trails are managed and maintained by the USDA Forest Service, non-system trails do not receive maintenance funding and often have issues related to poor construction and upkeep.
3/146	Trails Baseline	<p>Resource damage and user conflicts are occurring in some places as a result of the abundance of non-system trails, and can impact the recreation experience by causing unsafe trail conditions. Additionally, safety concerns during the hunting seasons are increasing as the level of use on the trails increases. The myriad of non-system trails through the Uwharrie NF makes it difficult for hunters to know what areas to avoid.</p> <p>With increasing trail use, many trails of all types are in need of heavy maintenance, reconstruction, or relocation. Trails that might have sustained the lower levels of use that existed when they were established are unable to sustain today's higher levels of use. Some trails are so entrenched, rocky, or steep, that use of the trail is unpleasant and unsafe for some users while other users actually value these conditions as providing a challenge. Limited trail maintenance and management funding is available for maintenance of system trails; however, dedicated trail volunteers have donated hundreds of hours of time to trail maintenance and have improved conditions in</p>
